## IX. Business

- 1) New
  - a. Presentation of Gerald White, Project Director –
  - AUI is picking up and moving out. We've asked that they take photographs of the
    entrance and exit areas within their jurisdiction. We have asked that they have all
    trenches are back filled, signed and fenced off all areas in preparation of next year.
  - 404 Permit was approved on 12/08/09.
  - Design is complete accept for Chalet 2G & Chalet 1A, Tracts D2 and F at El Vado Place
     We have been holding Chalet 1A because they are delinquent in their special levy assessment payments. We have sent demand letters to the owners of these properties.
     Therefore, we may need to foreclose on these properties.
  - Audit contract has been approved by the State Auditor with White, Samaniego & Campbell. They will begin on December 15, 2009.
  - Baptist Church at Via Grande Trail & South AF Road will be fully dedicated at the AAFPO meeting this evening. Carl Abrams stated that he met with Carl Nelson of Line of Sight regarding the additional survey work needed at these locations. He will have a draft at for the AAFP meeting. For only the southerly greenbelt crossing.
  - The NMFA loan issue has been put on the December 17, 2009 agenda so we may amend the loan agreement shortly. We are working with Paul Cassidy and Nann Winter regarding the amended loan agreement.
  - Carl Abrams stated that he has talked with Luis Ruiz at Kit Carson regarding the license agreement. He should have it completed by the end of the week. Gerald stated that we are still reviewing the issue regarding installation of conduit, but because of the amended loan agreement the cost will be an issue. Therefore, discussing this matter with AUI, we will need to go with the cheapest option. Luis stated that Alex is the contact for the South AF Road junction box. The junction box must be installed by Kit Carson.
  - Gerald indicated that the Sheehan invoices (#6 & 7 on the consent agenda) will be changed because 1.9 hours (approximately \$900.00 reduction) will be moved from one invoice to the other. Director Oliver made a motion to approve the invoices once the new invoices are submitted. Chairman LeBus seconded the motion. Motion carried 3-0.

- 1) Committee Reports
  - 1. Construction Committee Director Steve Oliver stated that the invoices for HDR and AUI were submitted to committee and recommended to the Board for payment.
    - Carl Abrams stated that AUI is demobilizing due to weather conditions. They have graded the roads and are good for winter. Manhole covers have been fenced. Emergency equipment will be able to have access.
    - Design plans are complete for 7 of the 9 sub-divisions. Design packages for the water tanks are pending.
    - AUI is 60% complete for the sewer. The last construction meeting will be next week.
    - 404 Permit received yesterday.

- 2. Grants Committee Carl Abrams stated that the USDA grants was put on hold until the 404 permit was obtained and we will follow-up on the RUS application to pursue
  - 3. Finance Committee Director Verry stated that Dan Rakes, Gerald White and Chuck Verry will be attending the NMFA December 17, 2009 meeting. Nann Winter stated that NMFA is willing to lend to the amounts in the Formation documents.
