PID Board Meeting Minutes February 10, 2010 at 1:30 p.m. at the Village Hall Meeting Room

- I. Call to Order Director Charles Verry called the meeting to order at 1:30
- II. Pledge of Allegiance Director Verry called for the Pledge of Allegiance
- III. Roll Call Present were Director's Verry and Steve Oliver. Also present by telephone were Vice-Chairman Daniel Rakes, Director Alan Young, Gerald White, Project Director and Penni Davey, District Administrator.
- IV. Approval of Agenda Director Oliver made a motion to amend the consent agenda item #10 to read \$8,488.68 in lieu of \$8,936.50. Vice Chairman Rakes seconded the motion as amended. The motion carried 3-0.
- V. Approve Minutes from the January 13, 2010 Board Meeting Director Oliver made a motion to amend the minutes to read item #8 under the consent agenda, payment was \$110,649.31 in lieu of \$113,291.76. Director Young seconded the motion as amended. The motion carried 3-0.

IX. Business

- 1) New
 - a. Presentation of Gerald White, Project Director
 - Design is 100% complete except for 2G and 1A which are 90%. The El Vado Place design is on hold as the Corp of Engineers has indicated we cannot build at the location shown in the formation documents. We are working with the owner and the Corp of Engineers to review alternate accesses.
 - 2008 Audit is complete and accepted by the State Auditors office.
 - Line of Sight Surveying has provided final documents drawings to wrap up the Baptist Church and Woodlands Drive easements. Angel Fire Resort Operations has approved the documents which will be presented this evening to the AAFPO Board for approval. Via Grande Trail South and Elk need more field work to complete.
 - 3rd Party Agreement with Kit Carson is pending KC's signature. Qwest design on South AF Road is waiting on Kit Carson drawings. Carl Abrams stated that KC will install junction boxes north of South AF Road Extension.
 - A request from Ron Glaser for final drawing in CC1-B will be provide in ½ sizes as well as the Schedule of Values.
 - In October, 2009, Molson Corbin completed a preliminary study for the Village of Angel Fire on their existing water system. The modeling analyzed pressure lines and areas both inside and outside the PID areas. BHI has modeled the PID zones with the NMED standard used today by the Village. The Village has agreed that the existing pressure requirements at the interfaces of 1,000 gal per minute and a minimum of 6" cannot be met in all cases. The Village asks that we contribute \$4,000 to review and define issues on the PID area. Molson Corbin has been asked to expand their scope to increase pipe size in the Village. Pressure values may be warranted and isolation values may be needed in emergency situations.
 - AUI is ordering pipe by February 26, 2010.
 - Carl Abrams and Glen Boone will meet to review detailed drawing for water system.
 - CC 1A & 2G water tank design is 90% complete.
 - Carl Abrams has talked with Karen Gallegos, NMED regarding funding in the Revolving Loan Fund. They have indicated that we are disqualified because there is no established public health need. Our best pursuit of additional funding is with PPRF and possibly the Water trust board of NMFA.
 - b. Consider and Approve AUI Amendment No.4 Agreement Director Oliver made a motion to approve the AUI Amendment No.4 Agreement. Director Young seconded the motion. Gerald White stated that all funds are available from NMFA therefore we will issue a Notice to Proceed to AUI. The motion carried 3-0.

 - Grants Committee -
 - 1. RUS ~ Carl Abrams reported that we will submit the USDA application although it does not look good for grants or additional funding.
