 - A. Presentation of Carl Abrams, HDR Engineering, Inc.
 - Funding Assistance with Paul Cassidy; USDA dependent on USACE review.
 - Meeting with Kit Carson, April 9th regarding Fiber optics stimulus funds
 - Continue to work on cost saving and task listing with AUI
 - Site visit w/ USACE on April 2nd was not as successful as hoped because they will
 want to come back to make sure we are not working in an area that is considered wetland or waters of the US. Therefore permits will not be signed until she is able to
 review the over all project.

 - Total Cost to be firmed up by April 29th

 - B. Presentation of Paul Cassidy, RBC Capital Markets
 - Time schedule of the adoption of the Loan Ordinance will be introduced today, Notice of intent to adopt the ordinance will be published in the Chronicle and Albuquerque Journal North. The 4/23/09 NMFA Board will grant approval of the loan ordinance. On May 6th and Special Board Meeting will be held to adopt the Loan Ordinance and then it will be published in the papers once again. Interest rates will be set on May 26th or 27th. NMFA has sized this loan for \$26,719,000. We do not believe we will need that amount but something less.
 - The final bond sizing needs to be known as soon as possible. The amount must be known for the construction cost by April 29, 2009.

• Doug Praw has prepared a resolution of a Notice to property owners of the right to prepay special levy. The owner will be obligated that the property owner will need to notify the District of their desire to prepay. The monies will need to be collected prior to the loan closing of June 18, 2009. Numbers should be available by May 6, 2009. The Notice is to be put on the web-site.

C. Introduction of Loan Ordinance 2009-1

- Doug Praw introduced the Loan Ordinance 2009-1 which allows the financing for road work, installation of PVC water lines and sanitary sewer line for the governmental unit to secure a loan agreement and reserve an amount of up to \$26,719,875. This will be paid by the special levy pursuant to section 5-11-1 ET Seq., NMSA 1978 to the New Mexico Finance Authority. This loan agreement is similar to the \$1M loan agreement closed on February 13, 2009. This will be adopted at the Special Board Meeting of May 6, 2009.
- Director Verry made a motion that a Notice of Intent be published to adopt the loan ordinance be sent to the newspaper. Director Oliver seconded the motion. Motion carried 4-0.
