

**VILLAGE OF ANGEL FIRE
PUBLIC IMPROVEMENT DISTRICT NO. 2007-1
RESOLUTION NO. 2**

WHEREAS, pursuant to Sections 5-11-1 through 5-11-27, NMSA 1978 as amended (the "Public Improvement District Act") and the Village of Angel Fire, New Mexico (the "Village") Resolution No. 2007-34, on February 14, 2008, the Village adopted Resolution No. 2008-07 (the "Formation Resolution") creating the Village of Angel Fire Public Improvement District No. 2007-1 (the "District"); and

WHEREAS, the Formation Resolution authorized the Board of Directors of the District (the "Board"), among other things, to: (i) finance and construct certain public infrastructure improvements ("Improvements") upon real property in the District ("Real Property"); (ii) impose a District special levy upon the Real Property within the District (the "District Special Levy") to finance the Improvements; and (iii) issue bonds in an aggregate principal amount not to exceed \$24,978,5250 to finance the Improvements; and

WHEREAS, the Formation Resolution also approved revisions to the General Plan and the Rate and Method of Apportionment of Special Levy ("Rate and Method") subject to an election required under the Public Improvement District Act; and

WHEREAS, the Rate and Method addressed the manner in which the District Special Levy will be established and provided sufficient detail to enable each owner within the District to estimate the maximum amount of the levy proposed; and

WHEREAS, the District was subsequently approved by an election of District Real Property owners held on April 21, 2008; and

WHEREAS, a Notice of Imposition of Special Levy was recorded in the real property records of Colfax County, New Mexico on June 4, 2008, which states the maximum annual amount of the District Special Levy that will be imposed, the method of apportionment of the District Special Levy and the District's procedures applicable to the foreclosure and redemption of delinquent levies; and

WHEREAS by virtue of imposing the District Special Levy on the Real Property, the District is subject to additional requirements set forth in (i) the Public Improvement District Act relating to the preparation of certain statements and estimates (the "PID Requirements") and (ii) Section 6-6-2, NMSA 1978 relating to the preparation of an annual budget and periodic financial reports (the "Local Government Division Requirements" and with the PID Requirements are collectively the "Additional Requirements"); and

WHEREAS, in compliance with the Additional Requirements, the District has prepared a Fiscal Year 2008-2009 Annual Report dated July 25, 2008, attached hereto as Exhibit A (the "Annual Report") which annual report also provides a budget for the District for the same fiscal year; and

WHEREAS, the Annual Report includes, among other things, the estimated operation and maintenance expenses of the District, costs of Improvements and amounts to be raised to pay special levy bonds; and

WHEREAS, in accordance with the Public Improvement District Act, the Annual Report and budget, including the estimated operation and maintenance expenses of the District, costs of Improvements and amounts to be raised to pay special levy bonds, was filed with the District clerk on July 25, 2008; and

WHEREAS, in accordance with the Public Improvement District Act, the Board has scheduled a hearing on the Annual Report and budget, including the estimated operation and maintenance expenses of the District, costs of Improvements and amounts to be raised to pay special levy bonds, for July 26, 2008, and notice of the consideration of the Annual Report and budget and hearing was published pursuant to the District's Open Meetings policy; and

WHEREAS, the Board desires to hear and take comment on the Annual Report and budget, including the estimated operation and maintenance expenses of the District, costs of Improvements and amounts to be raised to pay special levy bonds, approve the Annual Report, adopt the budget and submit that budget and the Annual Report to the Local Government Division as set forth in this Resolution.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE ANGEL FIRE PUBLIC IMPROVEMENT DISTRICT:

1. The Annual Report and budget included therein is hereby authorized, approved and adopted. The Chairperson, the Treasurer, and District administrator are authorized to make any changes, alterations or additions to the Annual Report and budget contained therein which may be necessary to remove ambiguities therefrom or otherwise clarify the provisions contained therein.

2. The Treasurer, the District clerk or District administrator are authorized and directed to cause a copy of the Annual Report and budget to be delivered to the Local Government Division before July 31, 2008.

3. Additionally, the Chairperson or his designee are authorized to take all actions necessary to cause periodic financial reports to be delivered, at least quarterly, to the Local Government Division in compliance with the Local Government Division Requirements.

4. The Chairperson or his designees shall take all action necessary or reasonably required to carry out, give effect to and consummate the transactions contemplated by this Resolution.

5. Severability. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

6. Effective Date. This Resolution shall be effective immediately.







INTRODUCTION

This report and budget provides the following information required pursuant to Section 5-11-23(F), NMSA 1978 (being a section of the Public Improvement District Act):

- Estimated operation and maintenance expenses of the district;
- Cost of public improvements to be financed by the special levy;
- All other expenditures for public infrastructure improvements and enhanced services proposed to be paid from the special levy; and
- Amounts raised to pay special levy bonds.

Any capitalized terms used herein and not otherwise defined shall have the meaning ascribed to them in the Rate and Method of Apportionment of Special Levy (the "Rate and Method") approved by the Board of Directors (the "Board") of the Angel Fire Public Improvement District No. 2007-1 (the "PID No. 2007-1") pursuant to Board Resolution 2008-07 adopted on February 14, 2008.

I. ESTIMATED OPERATION AND MAINTENANCE EXPENSES

PID No. 2007-1 will incur no operation and maintenance expenses with respect to public improvements. PID No. 2007-1 will incur administrative expenses in connection with the governance of PID No. 2007-1, the administration of PID No. 2007-1 Special Levy Revenue Bonds and the billing and collection of the special levies imposed by the Board pursuant to Board Resolution 2008-07 adopted on February 14, 2008 (the "Special Levy").

II. COST OF PUBLIC IMPROVEMENTS FINANCED BY SPECIAL LEVY

The Special Levy will fund the Administrative Expenses of PID No. 2007-1 and public improvements located within PID No. 2007-1.

III. OTHER EXPENDITURES FOR PUBLIC IMPROVEMENTS AND ENHANCED SERVICES

PID No. 2007-1 does not anticipate expenditures for other public infrastructure improvements or enhanced services.

IV. COLLECTIONS

The Special Levy was not collected in Fiscal Year 2007-2008.

V. ACCOUNT BALANCES

The account balances for the funds associated with PID No. 2007-1 as of June 30, 2008 are as follows:

VII. APPORTIONMENT OF SPECIAL LEVY

The Special Levy is apportioned to each parcel in accordance with the Rate and Method. The Maximum Annual Special Levy amounts, as set forth in the Rate and Method, are as follows in Table 2 below. The FY 2008-09 maximum and anticipated Special Levy amounts to be collected are shown by subdivision in Table 2 below. For FY 2008-09 the maximum and anticipated Special Levy amounts to be collected are equal. A listing of the Special Levy amounts by lot for FY 2008-09 is shown in Exhibit A.
