A RESOLUTION SUPPLEMENTING ORDINANCE NO. 2009-1 WHICH LOAN **DELIVERY** OF A **EXECUTION** AND THE AUTHORIZED AGREEMENT BY AND BETWEEN PUBLIC IMPROVEMENT DISTRICT 2007-**MEXICO NEW ANGEL** FIRE. OF VILLAGE THE IN "GOVERNMENTAL UNIT") AND THE NEW MEXICO FINANCE AUTHORITY IN THE MAXIMUM PRINCIPAL AMOUNT OF \$25,250,000; ESTABLSHING THE EXACT AGGREGATE PRINCIPAL AMOUNT, THE EXACT NET EFFECTIVE INTEREST RATE AND OTHER MATTERS WITH RESPECT TO THE LOAN AGREEMENT; AND RATIFYING ACTIONS PREVIOUSLY TAKEN IN CONNECTION THEREWITH.

WHEREAS, unless otherwise defined in this Supplemental Resolution or the context requires otherwise, capitalized terms in this Supplemental Resolution have the same meaning assigned to those terms in Section 1 of Ordinance No. 2009-1 ("the Parameters Ordinance") adopted by the Board of Directors of the Governmental Unit (the "Governing Body") on May 6, 2009; and

WHEREAS, the Supplemental Resolution is adopted pursuant to the Parameters Ordinance in order to approve the terms, aggregate principal amount, the net effective interest rates and other matters with the respect to the Loan Agreement; and

WHEREAS, the Governing Body has adopted the Parameters Ordinance which authorizes the issuance of the Loan Agreement and provides for the adoption of the Supplemental Resolution by the Governing Body to approve specific details of the Loan Agreement, and this Supplemental Resolution is adopted by the Governing Body for those purposes; and

WHEREAS, there have been presented to the Governing Body and there presently are on file with the District Clerk the Parameters Ordinance, this Supplemental Resolution and the form of the Loan Agreement, which are incorporated by reference and considered to be a part hereof; and

WHEREAS, all required authorizations, consents and approvals of any governmental body, agency or authority in connection with (i) the use and pledge of the Pledged Revenues for the payment of the Loan Agreement, and (ii) the authorization, execution and delivery of the Loan Agreement, which are required to have been obtained by the date on which the Supplemental Resolution is adopted have been or will have been obtained.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF PUBLIC IMPROVEMENT DISTRICT 2007-1 IN THE VILLAGE OF ANGEL FIRE, NEW MEXICO:

Section 1. <u>Ratification of Prior Actions</u>. All action previously taken (not inconsistent with the provisions of this Supplemental Resolution or the Parameters Ordinance) by the Governing Body and the officers of the Governmental Unit, directed toward the authorization, pledge, collection and distribution of the Pledged Revenues and the authorization, and issuance of the Loan Agreement is ratified, approved and confirmed and the Loan Agreement will mature on the dates and bear interest at the rates described below:

Section 2. <u>Parameters Satisfied</u>. All terms and conditions relating to the Loan Agreement set forth in this Supplemental Resolution are within the parameters established by the Parameters Ordinance.

- A. The Loan Agreement shall be for the aggregate principal amount of \$25,225,000 to provide funds to finance the acquisition, construction and completion of the Project as defined in the Term Sheet, and to pay the Processing Fee. Such amount does not exceed the maximum aggregate principal amount of \$25,250,000 permitted under the Parameters Ordinance.
- B. The net effective interest rate on the Loan Agreement is 5.2946%. Such amount does not exceed the maximum rate of 12% per annum permitted under the Parameters Ordinance.
- Section 3. Accounts and Funds. The Governing Body shall establish such Funds and Accounts as required by the Parameters Ordinance and the principal amount of the Loan Agreement of \$25,225,000 paid by the NMFA shall be deposited or used as follows: \$24,846,625 shall be deposited into the Project Fund for the acquisition, construction and completion of the Project as defined in the Term Sheet and \$378,375 shall be paid to the NMFA as the Processing Fee.

- Section 4. <u>Further Authorization</u>. Authorized Officers are hereby authorized to take all necessary action to effect the execution of the Loan Agreement.
- Section 5. <u>Parameters Ordinance</u>. Except with respect to the terms set forth in this Supplemental Resolution, the Loan Agreement is governed by the Parameters Ordinance. In the event of any conflict in the terms of this Supplemental Resolution and the Parameters Ordinance, the terms of the Parameters Ordinance shall prevail. The adoption of this Supplemental Resolution, and all procedures undertaken incident thereto, are in full compliance and conformity with all applicable requirements, provisions and limitations prescribed by the Constitution and laws of the State of New Mexico.
- Section 6. <u>Repealer Clause</u>. All bylaws, orders and resolutions, or parts thereof, inconsistent with this Supplemental Resolution are repealed to the extent of such inconsistency. This repealer shall not be construed to revive any bylaw, order or resolution, or part thereof, previously repealed.
- Section 7. <u>Effective Date and Publication</u>. This Supplemental Resolution shall be in full force and effect immediately upon adoption and approval by the Governing Body and its execution and approval by the Chairman of the Board of Directors. A title and general summary of the subject matter contained in this Supplemental Resolution shall be published in substantially the following form after adoption of this Supplemental Resolution.
