PUBLIC IMPROVEMENT DISTRICT NO. 2007-01 RESOLUTION NO. 2015-1

WHEREAS, pursuant to Sections 5-11-1 through 5-11-27, NMSA 1978 as amended (the "Public Improvement District Act") and the Village of Angel Fire, New Mexico (the "Village") Resolution No. 2007-34, on February 14, 2008, the Village adopted Resolution No. 2008-07 (the "Formation Resolution") creating the Village of Angel Fire Public Improvement District No. 2007-1 (the "District"); and

WHEREAS, the Formation Resolution authorized the Board of Directors of the District (the "Board"), among other things, to: (i) finance and construct certain public infrastructure improvements ("Improvements") upon real property in the District ("Real Property"); and (ii) impose a District special levy upon the Real Property within the District (the "District Special Levy") to finance the Improvements; and

WHEREAS, the District was subsequently approved by an election of District Real Property owners held on April 21, 2008; and

WHEREAS by virtue of imposing the District Special Levy on the Real Property, the District is subject to additional requirements set forth in (i) the Public Improvement District Act relating to the preparation of certain statements and estimates (the "PID Requirements") and (ii) Section 6-6-2, NMSA 1978 relating to the preparation of an annual budget and periodic financial reports (the "Local Government Division Requirements" and with the PID Requirements are collectively the "Additional Requirements"); and

WHEREAS, in compliance with the Additional Requirements, the District has prepared a Preliminary Budget for Fiscal Year 2015-2016 dated May 14, 2015, attached hereto as Exhibit A (the "Preliminary Budget") which Preliminary Report also provides a budget for the District for the same fiscal year; and

WHEREAS, the Preliminary Budget includes, among other things, the estimated operation and maintenance expenses of the District, costs of Improvements and amounts collected and to be raised to pay special levy bonds; and

WHEREAS, in accordance with the Public Improvement District Act, the Preliminary Budget, including the estimated operation and maintenance expenses of the District, costs of Improvements and amounts collected and to be raised to pay special levy bonds, was filed with the District clerk on May 14, 2015; and

WHEREAS, in accordance with the Public Improvement District Act, the Board has scheduled hearings on the Preliminary Budget, including the estimated operation and maintenance expenses of the District, costs of Improvements and amounts collected and to be raised to pay special levy bonds, for June 11 and June 25, 2015 with Final Action on the budget contemplated for July 9, 2015. Notice of these meetings (hearings) will be published pursuant to the District's Open Meetings policy; and

WHEREAS, the Board desires to hear and take comment on the Preliminary Budget, including the estimated operation and maintenance expenses of the District, costs of Improvements and amounts to be raised to pay special levy bonds, approve the budget and submit that budget to the Local Government Division as set forth in this Resolution.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE ANGEL FIRE PUBLIC IMPROVEMENT DISTRICT:

- 1. The Board shall hear and take comment on the Preliminary Budget on at least June 11 and June 25, 2015 with Final Action contemplated on July 9, 2015. After hearing and comment, the Chairperson, and the Treasurer may be authorized to make any changes, alterations or additions to the Preliminary Budget contained therein which may be necessary to remove ambiguities therefrom or otherwise clarify the provisions contained therein.
- 2. The Treasurer and the District Administrator are authorized and directed to cause a copy of the Preliminary Budget to be delivered to the Local Government Division before June 1, 2015.
- 3. The Treasurer and the District Administrator are authorized and directed to cause a copy of the District's final Annual Report (including the finally approved Budget) to be delivered to the Local Government Division before July 31, 2015.
- 4. Additionally, the Chairperson or his designee are authorized to take all actions necessary to cause periodic financial reports to be delivered, at least quarterly, to the Local Government Division in compliance with the Local Government Division Requirements.
- 5. The Chairperson or his designees shall take all action necessary or reasonably required to carry out, give effect to and consummate the transactions contemplated by this Resolution.
- 6. <u>Severability</u>. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

7. <u>Effective Date</u>. This Resolution shall be effective immediately.
